Ordering procedure

1. Send this completed form to the "IMBA - Team", either by email imba@ukhsa.gov.uk or by post (Internal Dosimetry Group, UKHSA - RCE, Chilton, Didcot, Oxon. OX11 0RQ UK).
2. On receipt of a completed order form and once the license fee has been paid in full, an installation package for the IMBA Software will be made available for digital download. (**N.B.** For speed, cost and environmental reasons, direct digital download is now the only method of delivery).
3. The cost of upgrades from previous versions of IMBA can be calculated using the formula (cost of new licence – cost of previous licence) + £1,000, where the cost of the previous licence exceeds that of the new licence the only charge will be a flat £1,000 administration fee.
