This course is designed for Environmental Health and Safety Regulators who are involved in the regulation and inspection of aesthetic lasers, sunbeds and light shows. The use of aesthetic lasers and intense pulsed lights for cosmetic treatments became exempt from regulation with the Care Quality Commission, in England, in 2010. The responsibility for the regulation of this sector in England falls to local authorities. Some local authorities can regulate these activities using existing local registration and licensing regimes.

This course will review the main applications and safety issues and will give a sound basis for the inspection of such practices. The guidance of the Medicines and Healthcare products Regulatory Agency (MHRA) will be covered.

The use of sunbeds has been regulated in England since April 2011. The underlying health issues and requirements of the Act will be discussed.

Lasers and powerful lamps and lights are also used at public entertainment venues. Again, the main applications will be discussed along with the safety issues. The practicalities of assessments and inspections, with reference to HSE guidance, will be covered.

The course will conclude with a delegate driven review of other laser and light applications and discussion on sources of further information.
