



UKHSA Validation Scheme for Laboratories

The validation scheme outlines requirements by which suppliers of passive radon detectors can demonstrate competence in the measurement of radon levels in UK dwellings. The scheme includes a review of the quality procedures used by each supplier, performance tests that assess their ability to measure radon by exposing detectors to known quantities of radon and guidance in the interpretation of the measured results.

The scheme only applies to long term measurements, those of three months or longer because radon exhibits diurnal, monthly and annual variation. Shorter measurements, and especially those of less than a month, may be useful for screening purposes where time is short, but give a less accurate assessment of the annual average radon concentration, and are not covered by this scheme.

The aim of the validation scheme is to ensure good laboratory practice, and to address issues such as data protection, record keeping and dealing with complaints from customers.

The government departments with responsibility for radon in dwellings have requested local authorities and the Northern Ireland Housing Executive to give favourable consideration only to grant applications which are supported by measurements carried out by laboratories successfully participating in the scheme.
